*Shifting into Behavior Intervention Plans that Work:

A BIP is not a plan for punishment or something used only when things go wrong. It's a strategic tool to prevent challenging behaviors before they occur, and when they do, to guide children toward positive outcomes through teaching, support, and reinforcement. The goal is to plan on purpose, not in crisis. In this training participants will learn: When a Behavior Intervention Plan is required; How to collaborate with families to create purposeful, effective plans; what components must be included and when a BIP should be reviewed and revised.





*Shifting into Meaningful Family Engagement: Engaging Parents as Partners

In this training we will explore the barriers families face when advocating for their child's educational needs and the common ground to restoring the parent/teacher relationship through communication and shared partnership.

*Shifting from Chaos to Calm: Out of the Box Strategies that Promote Peaceful Learning Environments

In this training, participants will learn how to identify and eliminate the invisible forces that promote chaos in the classroom. This chaos disrupts the student/teacher relationship as well as the student's success. Participants will learn the importance of self-awareness which can promote a peaceful and nurturing learning environment.
